VENDOR SET-UP: Vendor is responsible for their own set-up and display of their goods in their assigned area.

Vendor Avenue set-up must be COMPLETED by 8:00 p.m. on Thursday night - NO EXCEPTIONS. Security will be present every night. Take down must be AFTER the conclusion of the event on Sunday (aprx. 4:00). All booths must be open each day, all day, from 9:00 a.m. until the last horse and rider competes at the end of the day.

Railside Vendors Set-up time must be arranged with Jenny due to the competition schedule in the arena.

These items must be received before you can begin set-up:

- One signed copy of the Plantation Field contract
 - All fees paid for space
 - A **Certificate of Insurance** in the hands of the Plantation Field Committee
 - Insurance Requirements:
 - General Liability in an amount no less that \$1 million per occurrence
 - Worker's Compensation (except for sole proprietors) with the limits no less than \$500,000
- These insurance policies must:
- Be written by an insurance company qualified to do business in the State of Pennsylvania
 - Name the Plantation Field organization, the Plantation Field Board Members and Mr. Cuyler Walker as additional insureds.

The Certificate of Insurance must indicate that insurance coverage is in effect for the entire period of Thursday September 14 through Sunday September 17, 2017 and must contain a policy whereby Plantation Field shall receive at least ten (10) days prior written notice before the insurance carrier cancels or modifies such insurance.
